

Information on the processing of personal data according to art. 13 of the GDPR 2016/679 (General Data Protection Regulation, European regulation on the protection of personal data)

According to Article 13 of the General Data Protection Regulation no. 2016/679 (hereinafter, "GDPR"), Trentino Innovation Hub S.c.a.r.l., with registered office in Trento, Piazza Mancini n. 17 (hereinafter, "HIT"), Intesa Sanpaolo S.p.A., with registered office in Torino (TO), Piazza San Carlo, 156, (hereinafter, "Intesa Sanpaolo") and Assobiotec Federchimica with registered office in Milano, Via Giovanni da Procida 11 (hereinafter, "Assobiotec") and SPRING—*Sustainable Processes and Resources for Innovation and National Growth* Cluster Tecnologico Nazionale della Chimica Verde with registered office in Milano, Via Giovanni da Procida 11 (hereinafter, "Spring") as Autonomous Data Controller, herein provide information on the processing of personal data of users who, through the appropriate form, register for the event "BIOINITALY TRENTO ROADSHOW" pursuant to the public selection notice of 14.12.2018.

The processing of personal data is based on principles of correctness, lawfulness and transparency.

Personal data are collected for specific, explicit and legitimate purposes and are also adequate, relevant and limited to what is necessary with respect to the purpose for which they are collected and processed.

Personal data will be updated periodically in accordance with the purposes for which they are processed and they will be stored in such a way as to allow identification of data subjects for a period of time not exceeding the achievement of the purposes for which the data are processed and in such a way as to guarantee adequate security.

1. Purpose of the processing and mandatory conferment

The personal data you provide – as identified or identifiable individual – are processed by HIT, Intesa Sanpaolo, Assobiotec or Spring to carry out the procedure related to the abovementioned selection notice and, in particular, for the purpose of (i) managing the organization of the event; (ii) complying with any contractual obligation deriving or connected thereto; (iii) fulfilling any obligation deriving from national and European legislation.

In accordance with such purposes, the Parties will exclusively process personal data such as name and last name, address and contact numbers.

The provision of personal data and the consent to process them are necessary to follow up on your request; consent to the processing of your personal data for any additional purposes is optional.

Subject to specific and optional consent, separate and apart from the one required for the participation in the event, the Parties will send you communications related to the future edition of the event or similar events.

2. Processing methods, automated decision-making processes and data retention times

The processing of your personal data is carried out by means of information technologies, although potential processing in paper form are not excluded. Personal data are processed using appropriate measures to guarantee confidentiality, prevent loss, illicit and incorrect use and prevent access by unauthorized third parties.

No automated decision-making processes are used to process your personal data.

Your personal data, collected through the registration form, will be stored for the time necessary to fulfill the purposes listed above, except for any optional express consent granted separately.

The Parties will comply with any legislation requiring longer retention time.

3. Communication, location of servers, dissemination and transfer of data to third countries or international organizations

In order to manage the event, the Parties might need to avail itself of third parties with whom it collaborates and which are identified as Data Processor. Such third parties might be consultants, professionals and partners of the event, as well as service providers supporting the management and maintenance of the

infrastructure that allows the registration and management of the event. Should it be necessary, personal data might be communicated to public entities at local, national and/or European level.

Your personal data will be stored on servers located within the European Union or managed by companies that comply with the Privacy Shield requirements, guaranteeing a process of personal data in line with European security standards.

Your personal data will not be transferred to third countries or international organizations outside the EU.

4. Rights of the interested party and complaint to the Privacy Guarantor.

You have the right to request us at any time access to your personal data, their modification, integration or deletion, and to limit or oppose their processing for legitimate reasons, as well as their transfer to another Data Controller. Written response will be provided within 30 days.

To exercise the rights provided by the law, including the revocation of your consent, you can contact the Parties at their registered office address or by email at privacy@trentinoinnovation.eu.

Should you considered that your personal data are illegitimately processed, you can also submit a complaint with the National Supervisory Authority.
